Reviewer #1: This study is important particularly with regard to ergonomics and solutions during the smartphone usage in sitting and laying down positions. However, there are many aspects in which the authors could expand their aim and also analysis of the data. I have outlined various questions need to be addressed for improving this work.

1. Generally, you introduction session needs to be substantially revised, as you failed to establish the fundamental rationale of your study. You should describe clearly what previous studies found, what limitations they had, then you can identify the research gap.

Why were you interested in investigating it? The recently published studies focused on the smartphone users can be reviewed and cited (<https://dx.doi.org/10.3233/WOR-205148>, <https://doi.org/10.1108/IJWHM-06-2020-0104>, <https://doi.org/10.1080/10803548.2020.1827528>, <https://doi.org/10.1007/s00500-021-05592-w>, <https://doi.org/10.1080/10803548.2020.1827561>, <https://doi.org/10.1080/10803548.2021.1979318>, <https://doi.org/10.3390/ijerph18136718>, <https://doi.org/10.3390/ijerph18168680>).

2. The authors seem to have left out this important link of theory/model in relation to the issue being examined. Perhaps theories/models such as Karsh (2006), Sauter and Swanson (1996), and other relevant theories/models should be included in this section to highlight the importance of the theories/models in guiding the study.

3. How the questionnaire was developed? Neither justification of various items nor any supporting literature.

4. The results are of some interest but the authors could elaborate further on the practical implications of their findings.

5. The discussion section needs more information particularly in relation to the theory/model of MSD with regard to the findings of the study.

6. The implication is not clear concerning what should be done for those respondents who have to learn from home and their susceptibility to MSD due to the usage of smartphone during learn from home situations.

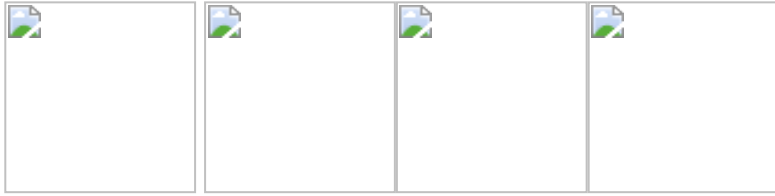

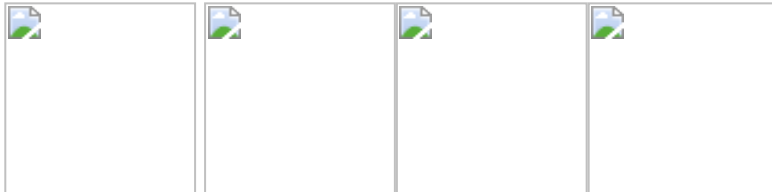
