Comments to the Author

Thank you for the thorough revisions. There are just a few revisions still required.

1. Please review the meaning of triangulation. It seems you describe it as having several people read the same transcripts. Usually it is when you have two or more sources of information e.g. FGD and IDI/observations, and that you bring the findings from these various sources together (triangulate) to provide validity to the findings.
2. I apologize for the lack of clarity in the comment about your conclusion (reviewer 2). What I am wanting you to reflect upon is the concept of Surveillance and Response – as an intervention – as described by WHO in the Global Technical Strategy. If you have good surveillance but do not respond, or respond adequately, to the findings of the surveillance – then it does not help address the malaria problem nor its control/elimination.
3. In results line 207 you start by saying 15 in-depth interviews but then say you had 16 informants?
4. Line 672. Should remove “at the least”
