ABSTRACT

This research is entitled an analysis of violating maxims in cooperative and politeness principles in stand-up comedy show by Trevor Noah. The aims of this research are (1) to identify the types of violating maxim of cooperative principles in stand-up comedy show by Trevor Noah, (2) to identify the types of violating maxim of politeness principles in stand-up comedy show by Trevor Noah, and (3) to find out the aims of the violation of cooperative and politeness principles in stand-up comedy show by Trevor Noah.

This research is a qualitative descriptive research. The data in this research are Trevor Noah's utterances in his stand-up comedy shows taken from his YouTube channel. The writer analyzed the data obtained using the *Simak Bebas Libat Cakap* technique (Uninvolved Conversation Observation Technique) and note-taking technique. To analyze the data, the writer used a descriptive analysis method based on Grice's theory of cooperative principles and Leech's theory of politeness principles.

The result of this research shows that there are 54 utterances containing humor in Trevor's stand-up comedy show which violated cooperative and politeness principles. The most frequent violations of Grice's cooperative principles were in a form of relevance maxim and manner maxim, each of which was violated 9 times. Meanwhile, Leech's politeness principles mostly were violated in a form of approbation maxim and sympathy maxim, each of which was violated 6 times. Apart from that, in this research, the writer found 2 purposes of violating maxim of cooperative and politeness principles in stand-up comedy show by Trevor Noah, namely to be funny and criticize.

INTISARI

Penelitian ini berjudul analisis pelanggaran maksim dalam prinsip kerjasama dan prinsip kesopanan dalam pertunjukan stand-up comedy Trevor Noah. Tujuan dari penelitian ini adalah (1) untuk mengidentifikasi jenis-jenis pelanggaran maksim dalam prinsip kerjasama dalam pertunjukan stand-up comedy Trevor Noah. (2) mengidentifikasi jenis-jenis pelanggaran maxim dalam prinsip kesopanan dalam pertunjukan stand-up comedy Trevor Noah. And (3) untuk mengetahui tujuan dari pelanggaran prinsip kerjasama dan prinsip kesopanan dalam pertunjukan stand-up comedy Trevor Noah.

Penelitian ini merupakan penelitian deskriptif kualitatif. Data dalam penelitian ini merupakan tuturan-tuturan Trevor Noah dalam pertunjukan stand-up comedynya yang diambil dari kanal YouTube-nya. Penulis menganalisi data yang didapat menggunakan teknik Simak Bebas Libat Cakap (SBLC) dan Teknik mencatat. Untuk menganalisis data, penulis menggunakan metode deskriptif analisis berdasarkan teori prinsip kerjasama Grice dan prinsip kesopanan Leech.

Hasil penelitian menunjukkan bahwa terdapat 54 tuturan yang mengandung humor dalam stand-up comedy Trevor Noah yang melanggar prinsip kerjasama dan prinsip kesopanan. Pelanggaran prinsip kerjasama Grice paling banyak terjadi adalah pelanggaran maksim relevansi dan maksim pelaksanaan, masing-masing dilanggar 9 kali. Sedangkan pelanggaran prinsip kesopanan Leech dalam stand-up comedy Trevor Noah paling sering terjadi adalah pelanggaran maksim kemurahan dan maksim kesimpatian, masing-masing dilanggar sebanyak 6 kali. Selain itu, dalam penelitian ini peneliti menemukan 2 tujuan pelanggaran prinsip kerjasama dan kesopanan dalam stand-up comedy Trevor Noah yaitu untuk melucu dan mengkritik.
