However, in contemporary contexts, it has become associated with various conflicts and extremist groups, making its use highly sensitive and potentially controversial. This historical weight can lead to significant misinterpretation or offense, particularly in media representations that might amplify these associations [9].

To navigate these sensitivities, filmmakers may choose to replace "jihad" with "crusade," a term that, while still denoting ideological conflict, lacks the specific religious connotations of "jihad." [10] The use of "crusade" may be seen as a way to mitigate the risk of misinterpretation or inflammatory reactions, thereby facilitating a broader reception without the same level of controversy Jones [11]. This shift reflects a strategic adaptation in media narratives to address the complexities of representing sensitive religious concepts while maintaining thematic coherence [12].

Previous Studies

McLaughlin (2015) explores how the term "jihad" is adapted in the film versions of Dune, focusing on the 1984 David Lynch adaptation and the 2021 Denis Villeneuve film. The study examines how these adaptations modify or replace "jihad" to avoid religious controversy and address contemporary cultural sensitivities [13]. McLaughlin argues that these changes impact the portrayal of ideological conflicts in the narrative, affecting viewers' understanding

of the story's themes of power, religion, and revolution. The research highlights the challenges filmmakers face in balancing the original novel's vision with the need to engage modern audiences without causing offense.

Next previous research explained about the political and cultural motivations behind the shift from "jihad" to "crusade" in the film adaptations of Dune by Roberts [14]. The study analyzes how this change reflects broader trends in media sensitivity and political correctness, exploring the implications for the narrative and audience reception. Roberts argues that the replacement of "jihad" with "crusade" was driven by a desire to avoid the complex and potentially inflammatory associations of "jihad" in contemporary contexts. This alteration, while reducing the risk of controversy, also affects the portrayal of ideological conflicts within the story, influencing how audiences interpret the themes of power and religious struggle in Dune.

Last, Williams focusing on how terms like "jihad" and "crusade" are employed to critique political and religious ideologies within the narrative [15]. The study explores how Herbert's use of these terms functions as a commentary on power structures and ideological conflicts, revealing the layers of meaning embedded in the novel's depiction of struggle and conflict. 


Diagram 2. Research Method
