



ABSTRACT

This study was titled *A Study on Victorian Women: Écriture féminine in Selected Poems of Emily Brontë*. It applied the theoretical approach of *Écriture féminine* (1979) by Hélène Cixous. The aims of this research were to analyse the study if Victorian women especially in the patriarchal rules as seen in selected poems of Emily Brontë.

A qualitative method was used in this study for collecting data, and data sources and data collection materials were obtained in library research. The subject of this research from the selected poems of Emily Brontë and the object in this research is the Victorian women that analysed the theory of *écriture féminine* by Hélène Cixous. This research is the selected poems of Emily Brontë, and the object in this research is the Victorian women who analyzed the theory of *Écriture féminine* by Hélène Cixous. This research shows that Emily Brontë poems provide an individual portrayal of female subjectivity and freedom while also challenging typical Victorian social norms, also proposing that her poetic interpretations make a significant contribution to the conversation about women's literary voices throughout the Victorian era.

The researcher concluded that the Victorian women experienced repression from society norms such as patriarchy, women as angles of home and the lack of freedom to gain voices. This issues challenges Emily Brontë, as women writer, to represent women's feelings and experiences, throughout her poems.

INTISARI

Penelitian ini berjudul *A Study on Victorian Women: Écriture féminine in Selected Poems of Emily Brontë*. Penelitian ini menggunakan pendekatan teoritis dari *Écriture féminine* (1979) oleh Hélène Cixous. Tujuan dari penelitian ini untuk menganalisis studi tentang wanita Victoria terutama dalam aturan patriarki seperti yang terlihat dalam pilihan puisi-puisi milik Emily Brontë.

Metode kualitatif digunakan dalam penelitian ini untuk mengumpulkan data, dan sumber data serta bahan pengumpulan data diperoleh melalui penelitian kepustakaan. Subjek penelitian ini adalah puisi-puisi terpilih dari Emily Brontë dan objek dalam penelitian ini adalah perempuan Victorian yang dianalisis dengan teori *écrɪtūrē féminīnē* oleh Hélène Cixous. Peneliti menyimpulkan bahwa perempuan Victorian mengalami penindasan dari norma-norma masyarakat seperti patriarki, perempuan sebagai pengatur rumah tangga, dan kurangnya kebebasan untuk bersuara.
